
# Ontario Senior of the Year

### **INFORMATION ON FENCES**

that a fence is required for a swimming pool? "Every owner of a swimming pool must enclose and maintain a fence and a gate around the pool. The fence must be at least 4 feet high and requires a gate at least 4 feet high with self-latching devices placed at the top and on the inside of the gate. A permit must be obtained through Lambton County Building Department.

Otherwise, a permit is not required for a fence, but it is your responsibility to ensure that the fence including the fence posts are located solely on your property. If you are not sure where your property line is, you should get a survey. The Property Standards By-Law states that "all fences must be maintained in good repair, free from accident hazards and protected by paint, preservative or other weather resistant material." A fence is defined as a wall (other than the wall of a building) gate or other barrier, constructed of wood, masonry, metal, vinyl, plastic or other manufactured material, which is continuous throughout its entire length, save and except where access areas and lines of sight are required for safety purposes; and does not include agricultural fencing. Fences must be maintained in a safe and structurally sound condition. Pallets or tires are not considered fences, and are not permitted.



**Did you know...** chickens, roosters, ducks, geese, turkeys etc are considered "farm animals" and **are not** permitted in residential areas.

**Did you know...** you could be subject to a \$500 fine for burning without a burn permit? In order to avoid a fine, please ensure you bring in a completed Burn Notification Form to the Municipal Office during business hours, or contact staff at 519-692-5148, at least



48 hours prior to the burn. This gives staff enough time to notify our partner fire departments.

ATTENTION FARMERS BRINGING HARVEST TO THE SOLIO AGRICULTURE FACILITY IN RUTHERFORD – PLEASE <u>DO NOT</u> PARK IN FRONT OF THE DAWN-EUPHEMIA FIREHALL ON LAMBTON LINE. EXITS MUST BE CLEAR AT ALL TIMES.

#### **OUTDOOR BURNING**

- Burning the following material is prohibited: Industrial, agricultural, or domestic waste; Petroleum Products, Rubber, Painted Lumber, Mixed Demolition Material, and other material specified in the Environmental Protection Act. Check the by-law for specifics.
- You must be the registered owner or have permission of the registered owner to conduct a burn.
- Only recreational burning, including burning of yard waste and burn barrels are permitted in residential areas.
- No burning between the hours of sunset and sunrise.
