In October 2020, MPV Wifi implemented "Fibre-tothe-Home (FTTH) technology" in both Shetland and Florence and offered a wide range of other comparable broadband internet access services to the rest of the Township. ## **Farm Tax Program**

One way the Ontario Government supports agriculture, is through the "Farm Tax Program". The farm residence and one acre of land surrounding it are taxed at the residential rate, and if eligible, the remaining farmland is taxed at no more than 25% of the municipality's residential property tax rate. Agricorp, the Municipal Property Assessment Corporation (MPAC) and municipalities work together to administer this Program.



You must inform Agricorp of any changes to your farm property that may affect your eligibility, such as changes to your land use, property rental arrangements, farm business structure, income, FBR status or exemption status, but most common, is when there is a change to ownership, or expanding an existing operation on farm parcel, the farmland automatically loses its "farm class status" and converts back to "residential". You can verify your property status by checking your **Annual Assessment Notice received** from MPAC in November. Contact Agricorp if the status has inadvertently changed, to ensure that the land continues to be taxed at the farm tax rate. For more information, call 1-888-247-4999 or www.agricorp.com/farmtax

## **Property Standards Complaints**

The Property Standards and Tidy Yard By-Laws set out minimum standards to ensure owners maintain their property to a minimum standard.

Nobody likes to receive a complaint about their property. However, staff are obligated to investigate the validity of the complaint and take action if needed. Typically, staff will send the owner a letter asking them to rectify the matter by a certain date. Most owners work cooperatively with staff, and no further action is required. However, where an owner ignores the request or fails to comply, then the Township engages the services of Lambton County By-Law Enforcement who will issue a formal "Order" on the property to bring the property into compliance within a specific time frame. Costs associated with enforcement are passed on to the owner.

The Township works on "complaintbased", so if you receive a request to clean up your property, it is because someone has complained about your property not because the Township is "picking on you" or "targeting you". So respectfully please work cooperatively with our staff to rectify the situation quickly whether it is picking up vour garbage, cutting your weeds/grass, or removing refuse on vour property. Keep in mind, having Township staff deal with initial complaints, saves significant dollars to the tax payers. So, let's all work together to keep our community looking nice.

#### **UPDATE ON 2020 PROJECTS**

**Structure Replacement:** There were 2 major structures replaced in 2020 (1) the 100m large diameter culvert in Oakdale; and (2) the concrete bridge structure with a large diameter elliptical culvert on Tramway Road.

Public Works staff also replaced 7 other large diameter culverts and 60 small culverts throughout the Township.

**Hardtop Treatment:** Marthaville Road from Lambton Line to Bentpath Line received hardtop resurfacing in 2020.

**New Waterline:** 4.2 kms of new waterline was installed on Esterville Road adding 8 new water connections to the system!



## A LOOK BUDGET

The 2021 budget was passed with a 2.85% increase which can be attributed to the following:

- Ongoing and additional loss in Provincial OMPF Funding of \$48,700
- Combined insurance & OPP policing cost increases of \$30,000
- Increases to cost of gravel \$30,000 plus an additional \$50,000 included for Gravel Resurfacing
- Future COVID-19 related expenses \$66,000

Therefore, a residential ratepayer with a \$100,00 home will see an increase in Township taxes of approx. \$19/year.

**Prov/Fed Funding:** The Township received \$69,500 in COVID Relief Funding & Safe Restart Agreement Funding from the Provincial and Federal Government which will be used to offset potential costs related to COVID-19.

**Gravel:** An additional \$50,000 was added to the gravel budget, in an effort to restore gravel resurfacing to historical levels.

Hardtop Surface Treatment: Resurfacing of Marthaville Road, will continue north of Bentpath Line.

**Structure Replacement:** The concrete bridge structure at the north intersection of Cuthbert and Langbank Line will be replaced at an estimated cost of \$375,000.

Cairo Garage Expansion: Council applied for a \$100,000 grant through the "Investing in Canada Infrastructure Program - COVID-19 Resilience Infrastructure Stream - Retrofits and Repairs to Public Infrastructure", which if successful, will be used to build an addition to accomodate 2 new bays for storage of equipment, at the Cairo Shop.

Water Rates: Effective February 1<sup>st</sup>, water rates will increase from \$2.85 cu3 to \$2.95 cu3 due to increases to cost of water, and in accordance with the Township's Financial Plan for Water Distribution. The bi-monthly flat rate will also increase from \$22 bi-monthly to \$23 bi-monthly.

Wheelie Bins: No change to rates

MEMORIAL TREE PLANTING PROGRAM – Council is pleased to announce a new initiative whereby residents can plant a tree in memory of a loved one in a designated planting area at either the Rutherford Park, Community Centre or Shetland Park. For a reasonable fee of \$150,

applicants can select a tree from a list chosen specifically chosen for their growth potential in our region. Once a year a tree the trees will be planted. A record will be kept in a memorial registry and posted at the municipal office.

## Did you know... that a fence is required for a swimming pool?

"Every owner of a swimming pool must enclose and maintain a fence and a gate around the pool. The fence must be at least 4 feet high and requires a gate at least 4 feet high with selflatching devices placed at the top and on the inside of the gate. A permit must be obtained through Lambton County Building Department.

Water tokens are available for \$4/each or 3/\$10 (for Rutherford Water Station). Each token provides 250 imperial gallons of water.
