Open Meeting to Consider Young Drain

That Council hereby opens the Consideration Meeting at 6:30 pm for discussion regarding the Amended Young Drain Report, dated November 24, 2020. *Carried.*

The Chairman called the meeting to order. The *original* Young Drain Report dated August 25, 2016, was first presented to Council at a Public Meeting to Consider on September 19, 2016, followed by a subsequent Court of Revision date of November

7, 2016. At the Regular Council Meeting of December 5, 2016, the Drainage Superintendent presented Council with a Report advising that the sole proponent of the Young Drain had requested a different scope of work be considered. This request was received *after* the invited tenders had been opened and read. Council agreed at that time, to suspend any progress until further investigation and the report was referred back to the Engineer for recommendations. The Report has been amended and the new Report dated November 24, 2020, is before Council for consideration.

Engineer Ray Dobbin, PEng, Dobbin Engineering Inc., presented the amended Young Drain Report, Section 78, dated November 24, 2020, of which notice was sent to all affected landowners and parties as required by the Drainage Act, on December 21, 2020. He advised that the owner had requested changes to the original report and highlighted the changes being mainly the realignment of the drain, west of Downie Road. The estimated cost of the drain is \$356,831 with damage to crops included.

The landowner, Jeff Cross agreed that the report was self-explanatory, acknowledged the costs, and confirmed that "all was good". The Landowner questioned if there were any foreseeable reasons that would prevent him from bidding on the project during the competitive process. The Engineer advised that he was not aware of anything preventing a tender submission provided that all criteria and specs are met including insurance, WSIB, required deposits etc; however, final decision for awarding the tender lies with Council.

Council questioned the drain costs directly related to Department of Fisheries and Oceans (DFO), to which the Engineer responded they were "substantial".

The Chairman concluded the meeting by advising the public present of the appeal procedures under the Drainage Act, and advised that appropriate notices will be sent out to all affected owners as to the date of the Court of Revision. Council passed the following resolution:

Close Meeting to Consider-Young Drain

The draft budget including the 2021 Operating, Maintenance, Administration and Capital Budget was presented and reviewed by Council on January 11 and 18, 2021. The budget meeting was opened to the public for comment. No comments were received.

The budget estimates show a 2.85% or the average Residential Tax Class will see \$19.00 a year increase per \$100,000 of assessment or Farm Tax Class will see \$4.00 a year increase per \$100,000 of assessment. The Township tax levy for 2021 will be \$4,017,961 with the following changes:

•	Gravel resurfacing increase in quantity	\$50,000
•	COVID-19 potential expenses in 2021	\$66,000
•	Insurance Premium increase	\$11,851
•	Staffing full-time Treasurer position	\$44,438

The water rate increased to \$2.95 per m3 (from \$2.85 per m3) and the basic fixed charge increase to \$23.00 per bill (from \$22.00). Council adopted the 2021 Water Financial Plan covering period until 2026 at the January 18, 2021 Council meeting. The following resolution was passed:
