A request for Maintenance was received for the McCutcheon Drain, which after review, was determined to be a private drain. Both landowners met with Council and the Drainage Superintendent to discuss the potential for a "Mutual Drain Agreement" between the parties, under S.2. of the Drainage Act. The proposal from the Drainage Superintendent was for costs to be assessed at 33.3% for both owners and the Road Authority for Dawn-Euphemia at 33.4%. Options available to the parties included (1) Do nothing; or (2) Agree on a different ratio; or (3) Appoint an Engineer for a Municipal Drain Report. After a lengthy discussion, the parties agreed on the following ratio: 20%, Darcy Bedell; 40%, Darcy McCutcheon, and 40% Road Authority. The Drainage Superintendent will draft the agreement for signature by all parties.
