Kennel Definition

That By-Law 2013-46, a by-Law to provide for the Regulation, Restriction and Prohibition of the Keeping and the running at Large of Dogs; and By-Law 2014-54, Zoning By-Law, both be amended to reflect the same definition of “kennel”; the definition being “kennel” means any building, pen or other structure, but not including a building used for human habitation, in which a dog or dogs are kept, whether or not for breeding or boarding and in respect of which the owner has or is eligible to have issued by the Municipality, a kennel license pursuant to the regulations.; And that the Clerk prepare both amending by-laws for the next Regular Council Meeting. *Carried.*
