Delegation: D. Ewing, Fire Chief and S. Gawley, Deputy Fire Chief, DEFD 6:30 – 6:50 pm 2022 Summary of Fire Operation and Radio Dispatch

Chief Ewing and Deputy Chief Gawley presented Council with a report outlining the 24 calls in 2022 that the Dawn-Euphemia Fire Department responded to. An update was also provided regarding the current roster, members who have completed the Lambton Fire Academy and training with Brooke Fire Department. In-house training updates were also provided to Council, with an outline of the upcoming four months scheduled training. Council was provided with a breakdown of the financial impact in 2022.

Chief Ewing advised that he has been participating in the Lambton County Chiefs meetings, with discussions focusing on improvement options for Radio Dispatching. The options will allow for complete monitoring during the total length of each call through the Sarnia Police Service, instead of the current basic dispatch. Sarnia Police is in the process of meeting the new N911 requirements, and the upgrades to the system will include two additional operational channels. The Capital Costs of the upgrades are approximately \$202,510, with Dawn-Euphemia's share at estimated at \$9,400, with an additional annual operating cost per capita of \$4.00 for dispatch services. Two County of Lambton departments will transfer to the Sarnia Police radio dispatch in May 2023, with a goal of transferring the remaining participating departments in September 2023.
