A New Report for the 25th Sideroad Drain and Reid Drain Report dated July 20, 2023, was prepared by the Engineer Ray Dobbin of Dobbin Engineering and a new Meeting to Consider was scheduled after it was confirmed that some affected parties had not been notified of the first Meeting to Consider which was held on June 19, 2023.

At the first Meeting to Consider on June 19^{th,} the Clerk was presented with a letter received from Landowner, Mark McGuire, requesting the access culvert from Bentpath Line for Roll#40-149, be removed from the Engineer's Report. A copy of the letter was provided to the Drainage Superintendent and the Engineer, Ray Dobbin. The Engineer advised that the change was reflected in the assessment schedule and the New Report dated July 20, 2023, was presented at tonight's Meeting to Consider.

The Drainage Superintendent, Paul Dalton, provided a brief overview of the New Report, followed by Ray Dobbin, PEng, of R. Dobbin Engineering Inc., who provided a detailed presentation of the New 25th Sideroad & Reid Drain Report, dated July 20, 2023. Notice of the Meeting was sent to all affected landowners and parties as required by the Drainage Act, on August 1, 2023, including St. Clair Township, Lambton County and local Enbridge Gas Representatives.

The following comments were received from the public:

- 1. Mr. J.Langstaff questioned if the delay in the ditch cleaning caused by the Enbridge Gas Project would result in an increase in the cost. The Drainage Superintendent responded that the contractor that was hired to clean the ditch will be returning to clean the tailings at the expense of Enbridge Gas.
- 2. Mr. J.Langstaff questioned if the Drain is being cleaned on St. Clair Township's side? The Drainage Superintendent responded that it is his understanding that the work will be done.
- 3. Ms. L.Quiring questioned how the 1/3 grant on Agricultural Land zoned A1 would affect her. The Engineer advised that she can check the Agricultural Maps on the Ministry of Agriculture, Food and Rural Affair's website. There is a layer on the map that shows which properties are eligible for the grant. Applicants can apply prior to construction to be considered.

The Chairman concluded the meeting by advising the public present of the appeal procedures under the Drainage Act, and advised that appropriate notices will be send out to all those affected owners for the Court of Revision date once the Provisional By-Law was passed.
