2023-163 Councillor McGuire – Councillor LeBoeuf

That Council direct the Treasurer to proceed with the acceptance and paperwork of the RED grant for a new sound system and a new stove at the DECC estimated gross cost of \$71,000 of which a reward of \$21,300 less \$2,130 for GrantMatch fees for a total net grant of approximately \$19,170, the stove reserves allocation of \$19,000 and total net costs of approximately \$32,800. *Carried.*

Shetland Campground Flood August 24, 2023: The Administrator-Clerk and Public Works Superintendent collaborated on a power-point presentation to Council with photos and associated timeline related to the Shetland Campground Flood of August 24, 2023. Requests from the campers including extending the camping season by two (2) weeks, waiving the 2024 deposit for the 2024 camp season and refunds were discussed. Council was provided estimated costs of various options and the following resolution was passed:
