SCHEDULE OF ASSESSMENT - W.G. MCGUIRE DRAIN

The Court of Revision for the W.G. McGuire Drain met to consider the assessment schedule. The first Meeting to Consider the W.G. McGuire Drain, was held on June 19, 2023, and the following resolution was passed:

- 1. Konzelmann Farms Inc., landowner, requested that the new culvert be eliminated from the Report and that the existing culvert NW ¼ be replaced; and
- 2. Konzelmann Farms Inc., landowner, requested that the existing access to the SW ½ be eliminated. *Carried*

As a result, a New Report dated June 23, 2023, was generated by the Engineer with the changes being incorporated. A second Meeting to Consider the W.G. McGuire Drain was held on Monday, July 17, 2023, at 6:30 pm to consider the New Report dated June 23, 2023. Council accepted the New W.G. McGuire Drain Report, as prepared by R. Dobbin Engineering Inc., and directed the Drainage Superintendent to schedule the Court of Revision for Monday August 21, 2023 @ 6:15 pm. The Provisional By-law received first and second reading on July 17, 2023.

Notice of the sitting of the Court of Revision was forwarded to all required parties on August 1, 2023. There were no appeals received by the Clerk. The Chair informed the Court of Revision that the purpose of the meeting was to review the assessment schedules only, and that the Court of Revision had no authority to change the Engineer's Report in any way. The Schedule of Assessment may be altered but the total must remain the same. If one assessment is reduced, then the other assessments must be increased to balance.

The Court was advised that if the property owners were not satisfied with the assessments, they could appeal to the Drainage Tribunal. The process for appeal was reviewed and appeal forms and information on the appeal process are available through the Clerk's office.

There were no comments from the public as no one was in attendance. The following resolution was passed:
