Four Counties Health Services Foundation Fundraising Committee presented an update of services provided by the Hospital along with current fundraising efforts. The FCHS Foundation is currently fundraising for critical equipment needs, not supported by the Ministry of Health which includes a Piccolo Analyzer, IT Infrastructure, Bladder Scanner, Work Station on Wheels, Patient Watering Alarm, CADD IV Pump, Ultrasound Stretcher, iStat POC Analyzer, Treatment Table and Staff Education for a total appeal of \$137,494. FCHS will submit a grant application for Council to consider during budget deliberations, for the purchase of one (1) CADD IV Pump at a cost of approx. \$6,000.

Ken Philips presented on Category 3 Programs and Services that are no longer subsidized by the Municipal Levy or the Province, but considered valued programs such as School and Community Programs, and Private Land Stewardship. SCRCA requested that the Township consider funding these services (either partially or in full) through a 5-year cost apportioning agreement. Council passed the following resolution:

The Fire Chief Don Ewing and Deputy Chief Sott Gawley also presented Council with

a draft proposal to change the geographical fire response area of the Dawn-Euphemia Fire Department, to include the response boundary from the Sydenham River to Shetland Road. The Chatham-Kent Station 9 (Bothwell Fire Department) would continue servicing the fire response area east of Shetland Road and the other boundaries would remain the same (south of Bentpath Line to the Western boundary of the Township, being Limerick Road).
