John Collison, Overall Responsible Operator, led the 2023 Water Management Meeting. He presented the following reports: Internal Audit – Drinking Water Report, Dawn-Euphemia Distribution System Inspection Report, and the DWQMS Surveillance Audit Report. Mr. Collison also presented the DWQMS 2023 Management Review Report. He noted the identified areas for improvement and subsequent action taken. Mr. Collison discussed the costs to replace water lines and the current water rate, and proposed changes to these rates. Council passed the following resolutions:
